CITY OF TORONTO

BY-LAW No. 228-2007

To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Bloor Street West, Keele Street and Weston Road East Ramp from Walsh Avenue to Weston Road.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the words and figures:

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

2. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

Keele Street	West	Lawrence Avenue West and a point 106 metres south	Anytime

3. Schedule XI (No Standing) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

Bloor Street West (M.T. 10)	North	A point 70 metres west of Royal York Road and a point 14 metres east thereof	6:00 p.m. to 12:00 midnight Monday to Saturday and Public Holidays 1:30 p.m. to 12:00 midnight Sunday

4. Schedule XV (Prohibited Turns) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:
