CITY OF TORONTO

BY-LAW No. 231-2007

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Beresford Avenue, Evelyn Avenue, Morningside Avenue and Rennie Terrace.

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
