CITY OF TORONTO

BY-LAW No. 232-2007

To amend By-law No. 196-84 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Guestville Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Guestville Avenue	West and East	Lambton Avenue and Eglinton Avenue West	Anytime

2. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Guestville Avenue	East	Lambton Avenue and a point 43.0 metres south of Dennis Avenue	Anytime
Guestville Avenue	East	Dennis Avenue and a point 43.0 metres further south thereof	11:00 a.m. to 12:30 p.m., 2:30 p.m. to 3:30 p.m., 7:00 p.m. to 8:30 a.m., Monday to Friday; anytime, Saturday and Sunday
Guestville Avenue	East	Dennis Avenue and Eglinton Avenue West	Anytime
Guestville Avenue	West	Lambton Avenue and a point 30.5 metres further north thereof	Anytime
Guestville Avenue	West	A point 115.8 metres north of Lambton Avenue and Eglinton Avenue West	Anytime

3. That Schedule X of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>	<u>Column 5</u> <u>Maximum</u> <u>Period Permitted</u>
Guestville Avenue	East	Dennis Avenue and a point 43.0 metres further south thereof	8:30 a.m. to 11:00 a.m., 12:30 p.m. to 2:30 p.m., 3:30 p.m. to 7:00 p.m., Monday to Friday	10 Min.
