CITY OF TORONTO

BY-LAW No. 270-2007

To amend various parking by-laws to conform with the requirement of the *City of Toronto Act*, 2006 and to eliminate voluntary payment amounts from parking by-laws.

Whereas the *City of Toronto Act*, 2006 requires the imposition of minimum fines in respect of certain traffic offences, and whereas City Council has directed that the voluntary payment amounts for all parking offences be eliminated;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. By-law No. 34-93 of the former Borough of East York, "To provide for disabled person parking permit holders", as amended, is amended by inserting the following words and figures, after the words "a fine of" in section 10(A): "not less than three hundred dollars (\$300.00) and".
- 2. Municipal Code Chapter 183, Parking, of the former City of Etobicoke, as amended, is amended by inserting the following words and figures after the words, "a fine of", in § 183-31.A: "not less than three hundred dollars (\$300.00) and".
- 3. By-law No. 85-90 of the former Municipality of Metropolitan Toronto, "To authorize certain on street parking of vehicles operated by or for physically disabled persons", as amended, is amended by adding the following section: "6. Every person who contravenes any provision of this by-law is guilty of an offence and on conviction is liable to a fine of not less than three hundred dollars (\$300.00) for each offence."
- **4.** By-law No. 31770 of the former City of North York, "To regulate parking for disabled person parking permit holders", as amended, is amended by inserting the following words and figures, after the words "a penalty", in section 10(A): "or fine of not less than \$300.00 (three hundred dollars) and".
- 5. By-law No. 23059 of the former City of Scarborough, "To authorize certain on-street parking of vehicles operated by or for disabled persons", as amended, is amended by adding the following section: "2.1. Every person who contravenes any provision of this by-law is guilty of an offence and on conviction is liable to a fine of not less than three hundred dollars (\$300.00) for each offence."
- 6. By-law No. 23060 of the former City of Scarborough, "To prohibit the parking of vehicles in a parking area reserved for disabled parking permit holders", as amended, is amended by inserting the following words and figures, after the words, "a penalty" in section 7(1): "or fine of not less than \$300.00 and".

- **7.** By-law No. 24302 of the former City of Scarborough, "To regulate parking for disabled person parking permit holders", as amended, is amended by inserting the following words and figures, after the words "a penalty" in section 10(A): "or fine of not less than \$300.00 and".
- 8. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto, as amended, is amended by adding the following section, § 400-11A(3), as follows: "Despite § 400-11A(1), any person who contravenes any provision of § 400-52 is guilty of an offence and, upon conviction, is liable to a fine of not less than three hundred dollars (\$300.00) for each offence."
- 9. Municipal Code Chapter 965, Parking-Disabled-Off-Street, of the former City of York, as amended, is amended by inserting the following words and figures after the words, "fine or penalty", in § 965.3.1.: "of not less than three hundred dollars (\$300.00) and otherwise".
- 10. Municipal Code Chapter 965, Parking-Disabled-Off-Street, of the former City of York, as amended, is amended by inserting the following words and figures after the words, "fine or penalty", in § 965.3.2.: "of not less than three hundred dollars (\$300.00) and otherwise".
- **11.** Municipal Code Chapter 965, Parking-Disabled-Off-Street, of the former City of York, as amended, is amended by deleting § 965.3.4.
- 12. Municipal Code Chapter 966, Parking-Disabled-On street, of the former City of York, as amended, is amended by adding a new § 966.2.4 as follows: "Any person who contravenes any provision of this chapter is guilty of an offence and, upon conviction, is liable to a fine of not less than three hundred dollars (\$300.00) for each offence."
