CITY OF TORONTO

BY-LAW No. 295-2007

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting John Street and Widmer Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| John Street | East | Front Street West and Stephanie Street | Anytime |
| John Street | West | King Street West and Adelaide Street west | Anytime |

| Widmer Street | East | King Street West and Adelaide Street West | Anytime |

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| John Street | East | Front Street West and a point 30 metres south of King Street West | Anytime |
| John Street | East | A point 43 metres north of King Street West and Stephanie Street | Anytime |
| John Street | West | A point 43 metres north of King Street West and Adelaide Street West | Anytime |
| John Street | West | Wellington Street West and a point 30 metres south of King Street West | Anytime |

| Widmer Street | East | A point 43 metres north of King Street West and Adelaide Street West | Anytime |

C. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

|------------------|------------------|---|------------------|
| John Street | Both | A point 30 metres south of King Street West and a point 43 metres north of King Street West | Anytime |
| Widmer Street | East | King Street West and a point 43 metres north | Anytime |
