CITY OF TORONTO

BY-LAW No. 706-2007

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting lane first south of College Street and Palmerston Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A.** By deleting from Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

| (From Column 1) | (From Column 2) | (From Column 3) | (From Column 4) |
|---------------------------------------|---|--------------------|--------------------|
| Lane first south of College Street | Palmerston Avenue and Markham Street | Anytime | Westbound |

- B.** By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) |
|---------------------------------------|-------------------------------------|------------------|------------------|
| Lane first south of College Street | Euclid Avenue and Markham Street | Anytime | Westbound |

- C.** By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) |
|-------------------|------------------|---|------------------------|
| Palmerston Avenue | West | College Street and a point 61 metres south | 8:00 a.m. to 6:00 p.m. |

- D.** By deleting from Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

| (From Column 1) | (From Column 2) | (From Column 3) | (From Column 4) |
|--------------------|--------------------|---|---|
| Palmerston Avenue | Both | College Street and a point 68 metres south | 7:00 a.m. to 6:00 p.m., Mon. to Fri. |

E. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

| (From Column 1) | (From Column 2) | (From Column 3) | (From Column 4) | (From Column 5) |
|----------------------|--------------------|--|--|--------------------|
| Palmerston Avenue | West | Dundas Street West and a point 68 metres south of College Street | 10:00 a.m. to 6:00 p.m., from Dec. 1 of one year to Mar. 31 of the next following year, inclusive | 1 hour |

F. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) | (In Column 5) |
|----------------------|------------------|--|--|------------------|
| Palmerston Avenue | West | Dundas Street West and College Street | 10:00 a.m. to 6:00 p.m., from Dec. 1 of one year to Mar. 31 of the next following year, inclusive | 1 hour |
