**CITY OF TORONTO**

**BY-LAW No. 730-2007**

**To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Greenfield Avenue.**

The North York Community Council HEREBY ENACTS as follows:

1. Schedule "IX" (No Stopping) of By-law No. 31001 of the former City of North York is amended by deleting from Columns 1, 2, 3 and 4 the following:
