BY-LAW No. 743-2007

To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Richmond Street West.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the words and figures:

3. Schedule XI (No Standing) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the words and figures:

Richmond Street West	North	A point 53 metres east of Peter Street and Simcoe Street	2:00 a.m. to 6:00 a.m. Friday through Monday
