BY-LAW No. 746-2007

To amend City of Toronto Municipal Code Ch. 925, Permit Parking, regarding Cowan Avenue, Elm Grove Avenue, Fort Rouille Street, Gwynne Avenue, Melbourne Avenue, Spencer Avenue, Temple Avenue and Thorburn Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 925, Permit Parking, is amended as follows:

A. By inserting in Schedule A (Permit Parking), the following in alphabetical order by street name:
