BY-LAW No. 750-2007

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Granby Street and Mutual Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
