## **CITY OF TORONTO**

### **BY-LAW No. 752-2007**

#### **To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Shuter Street and Victoria Street.**

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Lane first east of Victoria Street	Dundas Street East and Shuter Street	Anytime	From south to north

B. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Shuter Street	South	Victoria Street and Bond Street	Anytime

C. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Shuter Street	Both	Victoria Street and Bond Street	Anytime
Victoria Street	East	Shuter Street and a point 60.2 metres north of Shuter Street	Anytime

D. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)	(From Column 5)
Victoria Street	East	A point 70.0 metres south of Dundas Square and Shuter Street	8:00 a.m. to 6:00 p.m., Mon. to Sat.	2 hours

E. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)	(In Column 5)
Victoria Street	East	A point 60.2 metres north of Shuter Street and a point 70 metres south of Dundas Square	8:00 a.m. to 6:00 p.m., Mon. to Sat.	2 hours

F. By deleting from Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Shuter Street	South	A point 36 metres east of Victoria Street and a point 18 metres further east thereof	Anytime
