# BY-LAW No. 873-2007

To amend former City of North York Zoning By-law No. 7625, as amended, with respect to lands municipally known as 84 Finch Avenue West.

WHEREAS authority is given to Council by Section 34 of the *Planning Act*, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and

WHEREAS Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the *Planning Act*;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. Schedules "B" and "C" of By-law No. 7625 are amended in accordance with Schedule "1" of this By-law.
- **2.** Section 64.23 of By-law No. 7625 is amended by adding the following subsection:

64.23(121) C1(121)

# **PERMITTED USES**

(a) The only permitted uses within the existing single storey dwelling shall be one residential dwelling unit, as well as medical and professional offices.

#### **EXCEPTION REGULATIONS**

(b) Gross Floor Area

The maximum gross floor area shall not exceed 217.8 square metres.

(c) Building Height

The maximum height shall not exceed 1 storey.

(d) Yard Setbacks

The minimum side yard setbacks are shown on Schedule "2" - C1(121).

(e) Lot Coverage

The maximum lot coverage of all buildings shall be 35%.

(f) Parking

A minimum of 4 parking spaces are to be provided.

(g) Fencing

A minimum 1.5 metre high opaque fence shall be provided along the north property line abutting the residential lands.

**3.** Section 64.25 of By-law No. 7625 is amended by adding Schedule "1" - C1(121) attached hereto.




