BY-LAW No. 905-2007

To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Seneca Avenue, Lippincott Street East, Feltham Avenue, Holmesdale Crescent and Ennerdale Road.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. That Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Seneca Avenue	South	Avon Avenue and Weston Road	Anytime
Lippincott Street East	South	Weston Road and the easterly terminus street	Anytime

2. That Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Seneca Avenue	South	Avon Avenue and a point 49 metres west of Weston Road	Anytime
Lippincott Street East	South	Weston Road and a point 54 metres east of Weston Road	Anytime

3. That Schedule XI (No Stopping) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Seneca Avenue	South	A point 49 metres west of Weston Road and Weston Road	Anytime

4. That Schedule XIX (Stop Signs) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1 and 2 of said Schedule the following:

<u>Column 1</u> <u>Intersection</u>	<u>Column 2</u> <u>Stop Streets</u>
Feltham Street And Spears Street	Feltham Street for westbound traffic
Ennerdale Road and Holmesdale Crescent	Ennerdale Road for north and southbound traffic
