CITY OF TORONTO

BY-LAW No. 1077-2007

To amend Municipal Code Chapter 441, Fees and Charges, to include fees and charges for enforcement activities in respect of marijuana grow operations.

WHEREAS the *City of Toronto Act, 2006* (the "*Act*") provides that, where a police force has notified the City that premises contained a marijuana grow operation, the City of Toronto shall ensure that an inspection of the lands and building is conducted within a reasonable period of time after the notification and that appropriate actions are taken for the protection of the health and safety of the public; and

WHEREAS the *Act* provides that Council may pass by-laws in respect of the health, safety and well-being, and protection of persons and property; and

WHEREAS the *Act* further provides that Council may pass by-laws to impose fees and charges for services or activities done by the City or its local boards, including the recovery of costs for administration and enforcement; and

WHEREAS public notice was given and a public meeting held before the Licensing and Standards Committee in respect of this matter;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Chapter 441, Fees and Charges, of the Municipal Code of The City of Toronto is amended by adding the following to Appendix "B" ("Fire and Police Inspection and Permit Fees") to the chapter:
