BY-LAW No. 1108-2007

To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Toronto Roads.

The Scarborough Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by striking out the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1) Highway	(In Column 2) Side	(In Column 3) From	(In Column 4) To	(In Column 5) Times or Days
Treewood Street	Both	Midland Avenue	Brockley Drive	Anytime

2. Schedule VIII (No Parking) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

Treewood Street	North	A point 45 metres west of Brockley Drive	15 metres further west	Anytime Disabled Excepted

Treewood Street	North	A point 60 metres west of Brockley Drive	Midland Avenue	Anytime
Treewood Street	South	Midland Avenue	Brockley Drive	Anytime

- 3.** Schedule XIX (Compulsory Stops) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1 and 2 of the said Schedule:

Carlingwood Court and Carlingwood Court	Carlingwood Court Southbound
Glenstroke Drive and Lockdare Street, East Intersection	Glenstroke Drive
Thistlewaite Crescent and Wyper Square	Thistlewaite Crescent
Wyper Square and Wyper Square	Wyper Square Northbound
