#### BY-LAW No. 1139-2007

# To dedicate certain land for public highway purposes to form part of the public highway Laura Ellis Court.

WHEREAS the City is the owner of certain lands acquired pursuant to the Committee of Adjustment Consent Decisions with respect to File Nos. B073/06SC and B104/06SC respecting the development of 74 and 78 Brumwell Street, dated October 24, 2006 and April 13, 2007, respectively; and

WHEREAS the Committee of Adjustment Decision with respect to 78 Brumwell Street directed that suitable arrangements be made for the lifting of a portion of the 0.3 metre reserve on Laura Ellis Court and in order to give effect to the Committee of Adjustment's Decision with respect to 74 Brumwell Street it is necessary to lift the reserve; and

WHEREAS Technical Services under the delegated authority in Works Committee Report 1, Clause 4, adopted as amended by City of Toronto Council on January 31, February 1 and 2, 2006 has approved the lifting of these reserves based on the satisfaction of the conditions contained in the Committee of Adjustment Decisions; and
