BY-LAW No. 1141-2007

To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Sentinel Road.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule "IX" (No Stopping) of By-law No. 31001 of the former City of North York is amended by deleting from Columns 1, 2, 3 and 4 the following:
