BY-LAW No. 1178-2007

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Ascot Avenue.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
