## **CITY OF TORONTO**

### **BY-LAW No. 1196-2007**

**To amend further By-law No. 92-93, a by-law “To regulate traffic on roads in the Borough of East York”, being a by-law of the former Borough of East York, regarding Gledhill Avenue.**

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by striking out the following words and figures where they appear opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(From Column 1 Road)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and Days)
Gledhill Avenue	East	Cosburn Avenue and Lumsden Avenue	Anytime

2. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and Days)
Gledhill Avenue	East	Lumsden Avenue and a point 65 metres north	Anytime
Gledhill Avenue	East	A point 28 metres north of Barker Avenue and Cosburn Avenue	Anytime

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and Days)
Gledhill Avenue	East	A point 65 metres north of Lumsden Avenue and Barker Avenue	5:00 p.m. of one day to 8:00 a.m. of the next following day, Monday to Friday; and Anytime Saturday, Sunday and Public Holidays
Gledhill Avenue	East	Barker Avenue and a point 28 metres north	9:00 a.m. to 2:30 p.m. and 3:30 p.m. of one day to 8:30 a.m. of the next following day, Monday to Friday; and Anytime Saturday, Sunday and Public Holidays

3. Schedule IX (No Stopping) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and Days)
Gledhill Avenue	East	A point 65 metres north of Lumsden Avenue and Barker Avenue	8:00 a.m. to 5:00 p.m., Monday to Friday except Public Holidays

4. Schedule X (Parking for Restricted Periods) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3, 4 and 5 of the said Schedule:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and Days)	(In Column 5 Max. Period Permitted)
Gledhill Avenue	East	Barker Avenue and a point 28 metres north	8:30 a.m. to 9:00 a.m. and 2:30 p.m. to 3:30 p.m., Monday to Friday	10 minutes
