BY-LAW No. 1255-2007

To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic of former Metropolitan Roads, regarding Broadview Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Schedule VIII (No Parking) of Metropolitan Toronto By-law No. 32-92, as amended, is further amended by striking out the following words and figures:
