## **CITY OF TORONTO**

## BY-LAW No. 1269-2007

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges, respecting fees applicable to taxicab owners and limousine owners and drivers, and to amend Chapter 545, Licensing, respecting training and refresher courses for taxicab owners and limousine owners and drivers.

WHEREAS the *City of Toronto Act*, 2006 grants the City of Toronto the authority to enact by-laws for the licensing, regulating and governing of businesses wholly or partly carried on in the City of Toronto; and

WHEREAS the City of Toronto has decided that it is in the public interest to require limousine owners and drivers, and taxicab owners to complete training in accordance with a curriculum established by Municipal Licensing and Standards and to ensure that further refresher training is periodically completed; and

WHEREAS the City of Toronto has decided that it is in the public interest to require persons holding a limousine drivers license to have basic first aid and cardiopulmonary resuscitation training and to require that such training be periodically renewed; and

WHEREAS the *City of Toronto Act*, 2006 grants the City the authority to enact by-laws imposing fees or charges upon persons for services or activities provided or done by the City or on its behalf; and

WHEREAS the City of Toronto has authorized the recovery of costs to the City of providing certain services or activities, as set out in Chapter 441, Fees and Charges, of the Municipal Code;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Appendix C, All Other Fees, Schedule 15, Municipal Licensing and Standards, of Chapter 441, Fees and Charges, is amended by inserting the following rows in Schedule 15 in accordance with the numerical order indicated:

2. Appendix C, All Other Fees, Schedule 3, Emergency Medical Services, of Chapter 441, Fees and Charges, is amended by adding the words "and limousine" in Column II of Line 11, following the words "CPR Course – Emergency First Aid Taxi".

- 3. In Municipal Code Chapter 545, § 545-473, Licenses and license applications, of Article XXXIX, Owners and Drivers of Limousines and Limousine Service Companies, is amended by adding the following to Subsection B:
  - (3) Successfully complete a five-day Limousine Driver Training Course provided by the Municipal Licensing and Standards Division; and
  - (4) Successfully complete a one-day first-aid and cardiopulmonary resuscitation course provided by Toronto's Emergency Medical Services (EMS), or by such agency as may be approved by the Executive Director of Municipal Licensing and Standards.
- 4. Article XXXIX, Owners and Drivers of Limousines and Limousine Service Companies, is amended by adding a new section, § 545-473.1, License renewal requirements, and adding section A to the new § 545-473.1 to state:
  - A. Once every four consecutive years, every applicant for the renewal of a license as a driver or an owner, if the owner drives a limousine, shall:
    - (1) Successfully complete the limousine driver/owner refresher training course provided by Municipal Licensing and Standards, which course shall address skills relating to limousine driving as set out in a curriculum approved by the Executive Director or his or her designate; and
    - (2) Successfully complete a one-day first-aid and cardiopulmonary resuscitation course provided by Toronto's Emergency Medical Services (EMS), or by such agency as may be approved by the Executive Director of Municipal Licensing and Standards.
