## **CITY OF TORONTO**

### **BY-LAW No. 1295-2007**

#### **To amend By-law No. 2958-94, of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Clearview Heights and Irving Road.**

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

From Column 1 <u>Highway</u>	From Column 2 <u>Side</u>	From Column 3 <u>Between</u>	From Column 4 Prohibited <u>Times or Days</u>
Clearview Heights	South	Trethewey Drive (east junction) and Keele Street	Anytime
Irving Road	North	Trethewey Drive and Keele Street	Anytime

2. Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

In Column 1 <u>Highway</u>	In Column 2 <u>Side</u>	In Column 3 <u>Between</u>	In Column 4 Prohibited <u>Times or Days</u>
Clearview Heights	South	Trethewey Drive and a point 43 metres east	Anytime
Clearview Heights	South	A point 63 metres west of Keele Street to a point 187 metres further west	9:31 a.m. to 10:59 a.m., 1:01 p.m. to 2:59 p.m. and 4:01 p.m. to 8:29 a.m., Monday to Friday
Irving Road	North	A point 20 metres west of Keele Street to a point 107 metres further west	9:31 a.m. to 10:59 a.m., 1:01 p.m. to 2:59 p.m. and 4:01 p.m. to 8:29 a.m., Monday to Friday

3. Schedule IX (No Stopping) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

In Column 1 <u>Highway</u>	In Column 2 <u>Side</u>	In Column 3 <u>Between</u>	In Column 4 Prohibited <u>Times or Days</u>
Clearview Heights	South	Keele Street and a point 63 metres west	Anytime
Irving Road	North	Keele Street and a point 20 metres west	Anytime
Irving Road	North	Trethewey Drive and a point 95 metres east	Anytime

4. Schedule X (Parking for Restricted Periods) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of the said Schedule the following:

In Column 1 <u>Highway</u>	In Column 2 <u>Side</u>	In Column 3 <u>Between</u>	In Column 4 Prohibited <u>Times or Days</u>	In Column 5 Maximum Period <u>Permitted</u>
Clearview Heights	South	A point 63 metres west of Keele Street and a point 187 metres further west	8:30 a.m. to 9:30 a.m., 11:00 a.m. to 1:00 p.m. and 3:00 p.m. to 4:00 p.m., Monday to Friday	10 minutes
Irving Road	North	A point 20 metres west of Keele Street to a point 107 metres further west	9:31 a.m. to 10:59 a.m., 1:01 p.m. to 2:59 p.m. and 4:01 p.m. to 8:29 a.m., Monday to Friday	10 minutes
