BY-LAW No. 1367-2007

To amend City of Toronto Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths and Bicycle Lanes, Chapter 903, Parking for Persons with Disabilities, Chapter 918, Parking on Residential Front Yards and Boulevards, and Chapter 925, Permit Parking, with respect to Offences.

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths and Bicycle Lanes, is amended as follows:
 - A. By inserting the words, "park," between the words, "shall" and "drive" in § 886-3A;
 - B. By inserting the words, "park," between the words, "shall" and "drive" in § 886-5A;
 - C. By inserting the words, "park," between the words, "shall" and "drive" in § 886-6C; and
 - D. by adding a new section § 886-13B as follows:
 - B. The owner of a vehicle may be charged with and convicted of a parking or other offence under this chapter for which the driver of the vehicle is subject to be charged unless at the time of the offence the vehicle was in the possession of some person other than the owner without the owner's consent.
- 2. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended by deleting § 903-13B and replacing it with the following:
 - B. The owner of a vehicle may be charged with and convicted of a parking or other offence under this chapter for which the driver of the vehicle is subject to be charged unless at the time of the offence the vehicle was in the possession of some person other than the owner without the owner's consent.

- 3. Municipal Code Chapter 918, Parking on Residential Front Yards and Boulevards, is amended by adding a new section § 918-28B as follows:
 - B. The owner of a vehicle may be charged with and convicted of a parking or other offence under this chapter for which the driver of the vehicle is subject to be charged unless at the time of the offence the vehicle was in the possession of some person other than the owner without the owner's consent.
- **4.** Municipal Code Chapter 925, Permit Parking, is amended by adding a new section § 925-6B as follows:
 - B. The owner of a vehicle may be charged with and convicted of a parking or other offence under this chapter for which the driver of the vehicle is subject to be charged unless at the time of the offence the vehicle was in the possession of some person other than the owner without the owner's consent.
