BY-LAW No. 1393-2007

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges, respecting Water Rates.

WHEREAS Council may pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of the City pursuant to subsection 259(1) of the City of Toronto Act, 2006, S.O. 2006, Chapter 11, Schedule A; and

WHEREAS City of Toronto Municipal Code Chapter 441, as amended, provides for the imposition of fees for services or activities provided or done by the City in respect to the supply of water and related services; and

WHEREAS the City considers it in its best interests that Appendix A, Schedule 3, Water to the City of Toronto Municipal Code Chapter 441, Fees and Charges, be amended to reflect the harmonization of water supply by-laws of the former municipalities through the enactment of Chapter 851;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Appendix A, Schedule 3, Water, of the Municipal Code Chapter 441, Fees and Charges, is deleted and replaced with the following:

Attachment No. 1 to this by-law entitled Toronto Municipal Code Chapter 441, Fees and Charges, Appendix A, Waste Collection and Disposal Fees and Water and Sewer Usage Rates, Schedule 3, Water.

2. This by-law comes into force on January 1, 2008.
