**CITY OF TORONTO**

**BY-LAW No. 1415-2007**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Charles Street West.**

The Council of the City of Toronto HEREBY ENACTS as follows:
