BY-LAW No. 544-2008

To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Upton Road, Mossbank Drive, Golfhaven Drive, Par Avenue, Drake Crescent, Cecil Crescent, Chipper Crescent, Nero Court, Scarboro Crescent and various other streets.

The Scarborough Community Council HEREBY ENACTS as follows:

- Schedule VIII (No Parking) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1) Highway	(In Column 2) Side	(In Column 3) From	To	(In Column 4) Times or Days
Upton Road	South	A point 75m east of the east limit of Warden Avenue	A point 70m further east	Anytime

- Schedule XVIII (Through Streets) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1 and 2 of the said Schedule:
