## CITY OF TORONTO

### BY-LAW No. 339-2009

#### **To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Barton Avenue, Berkshire Avenue, Claremont Street, Concord Avenue, Lewis Street, Milverton Boulevard, Murdock Avenue, Nanton Avenue and Sammon Avenue.**

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, of the City of Toronto is amended as follows:
  - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

Claremont Street	East	A point 110 metres south of Dundas Street West and a point 5.5 metres further south	Anytime
Lewis Street	East	A point 152 metres south of Queen Street East and a point 5.5 metres further south	Anytime
Lewis Street	West	A point 152.5 metres south of Queen Street East and a point 5.5 metres further south	Anytime
Sammon Avenue	North	A point 19 metres east of Kimbourne Avenue and a point 24.5 metres east of Kimbourne Avenue	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Barton Avenue	South	A point 35.5 metres west of Bathurst Street and a point 5.5 metres further west	Anytime
Berkshire Avenue	East	A point 54.5 metres south of Queen Street East and a point 5.5 metres further south	Anytime
Concord Avenue	East	A point 98.6 metres south of Hepbourne Street and a point 5.5 metres further south	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive
Concord Avenue	West	A point 101.6 metres south of Hepbourne Street and a point 5.5 metres further south	Anytime from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Milverton Boulevard	South	A point 82 metres west of Woodington Avenue and a point 5.5 metres further west	Anytime Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Murdock Avenue	South	A point 44 metres west of West Lynn Avenue and a point 5.5 metres further west	Anytime
Nanton Avenue	West	A point 72 metres north of Dale Avenue and a point 5.5 metres further north	Anytime
