**CITY OF TORONTO**

**BY-LAW No. 346-2009**

**To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Mount Pleasant Business Improvement Area and to establish a Board of Management for the Mount Pleasant Business Improvement Area.**

WHEREAS Council, by the adoption of By-law No. 1264-2008, designated an area along Mount Pleasant Road between Davisville Avenue on the west and 501 Mount Pleasant Road on the east and just north of Eglinton Avenue East, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

WHEREAS Toronto and East York Community Council has approved the establishment of a board of management for the Mount Pleasant Business Improvement Area, and appointed members to the Mount Pleasant Business Improvement Area Board of Management for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Mount Pleasant Business Improvement Area Board of Management;

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - A. The table in Schedule A, Boards of Management is amended by adding the new Mount Pleasant Board of Management as set out in Schedule A attached; and
  - B. Schedule A, Maps is amended by adding the attached Maps 1 and 2 of the Mount Pleasant Business Improvement Area.
2. A Board of Management for the Mount Pleasant Business Improvement Area is hereby established.

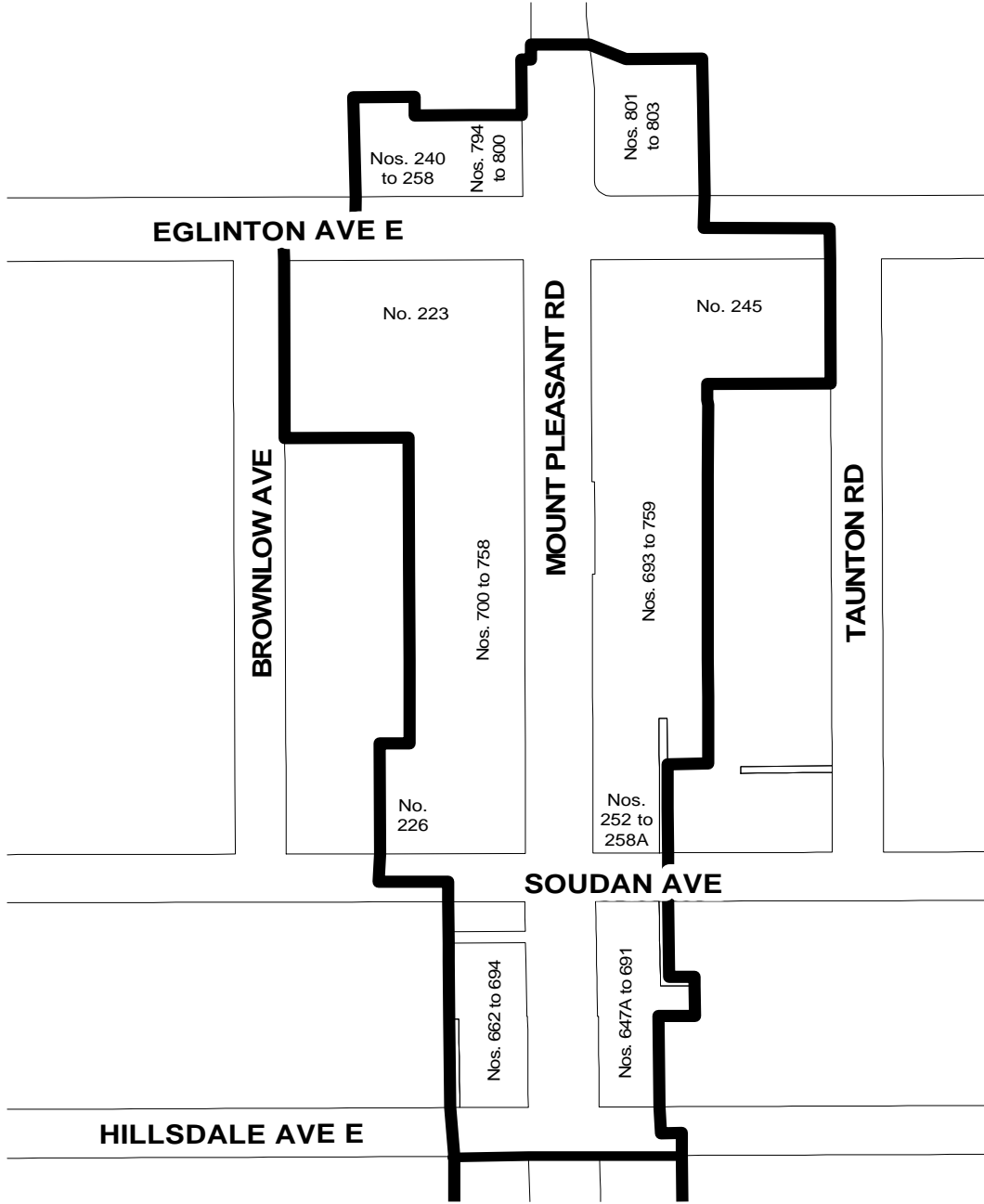

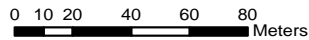

MAP 1 of 2**



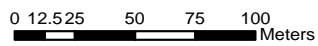
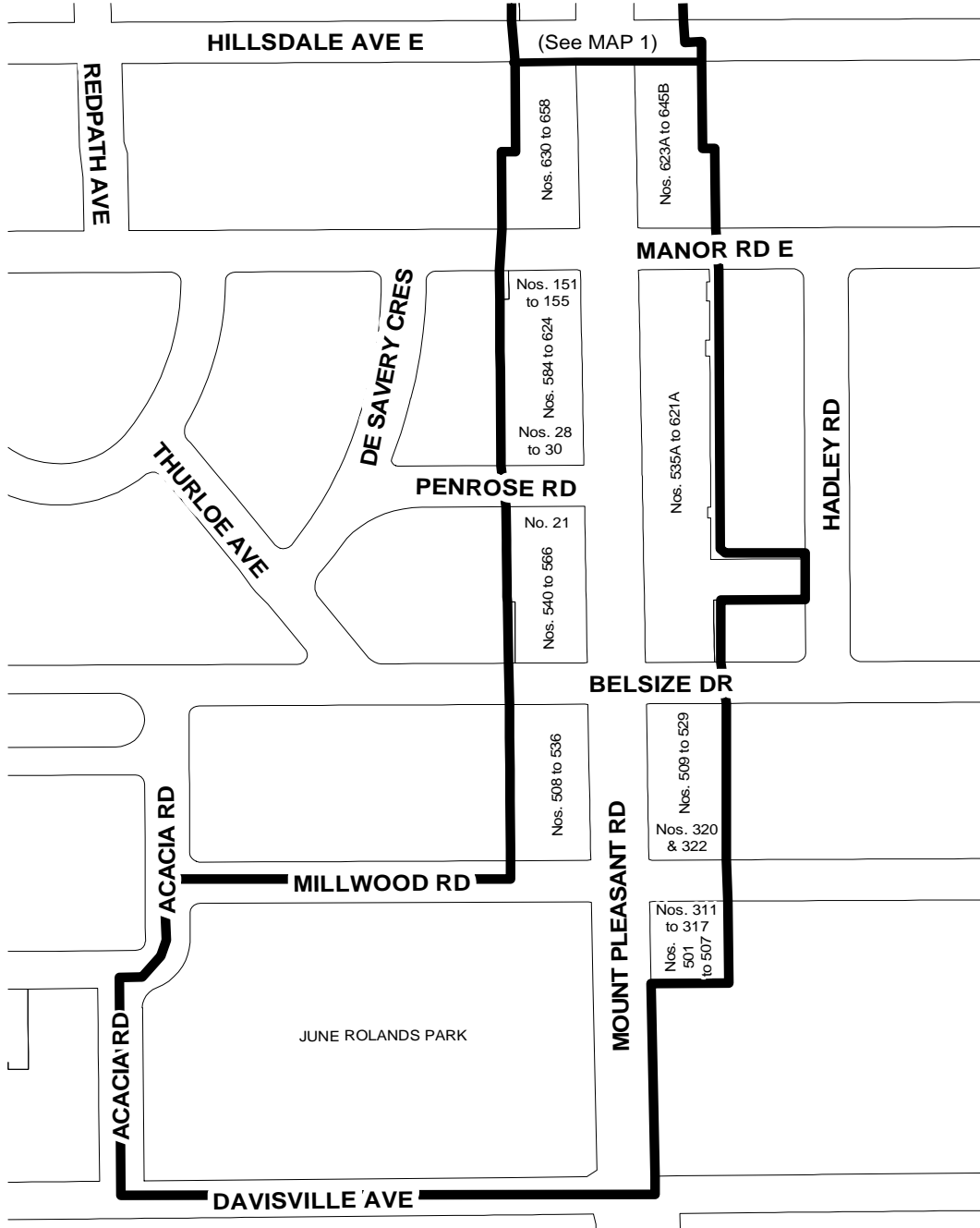
