CITY OF TORONTO

BY-LAW No. 349-2009

To amend City of Toronto Municipal Code Chapter 349, Animals and Chapter 441, Fees and Charges, to reflect the transfer of the City's Toronto Animal Services program from Toronto Public Health to the Municipal Licensing and Standards Division and to make technical amendments.

WHEREAS the City has implemented a Program Review Framework which involves regular review of program areas throughout the City; and

WHEREAS Toronto Animal Services was selected as one of ten programs to undergo a program review in 2006/2007; and

WHEREAS the City Manager's Office conducted the review and concluded that the City's animal services program should be transferred from Toronto Public Health to Municipal Licensing and Standards Division; and

WHEREAS this transfer necessitates changes to City of Toronto Municipal Code Chapter 349, Animals and Chapter 441, Fees and Charges; and

WHEREAS under § 169-26B Council has authorized the City Solicitor in consultation with the City Clerk to introduce bills to Council to make technical amendments; and

WHEREAS the technical amendments made by this by-law include the following amendments that are noted for reference purposes:

- (1) Chapter 349 is amended by deleting references to Medical Officer of Health and substituting therefore Executive Director of the Municipal Licensing and Standards Division where appropriate;
- (2) Chapter 441 is amended to relocate the fees for animal services from Toronto Public Health to Municipal Licensing and Standards; and

WHEREAS Article I, Interpretation, of Chapter 1, General Provisions, of The City of Toronto Municipal Code applies to City by-laws;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The chapters of The City of Toronto Municipal Code are amended as noted in the sections below.

2. Chapter 349, Animals.

Chapter 349, Animals, is amended as follows:

A. Section 349-1 is amended as follows:

(1) By adding the following definitions in alphabetical order:

EXECUTIVE DIRECTOR — The Executive Director of the Municipal Licensing and Standards Division of the City of Toronto or any person acting under his authority.

MUNICIPAL LICENSING AND STANDARDS DIVISION — The Municipal Licensing and Standards Division of the City of Toronto and includes employees thereof.

(2) By amending the definition of “MICROCHIP” by deleting the words “Medical Officer of Health” and substituting the words “Executive Director”.

(3) By amending the definition of “PROTECTIVE CARE” by deleting the words “Medical Officer of Health” and substituting the words “Executive Director”.

B. Section 349-9A is amended by deleting “Medical Officer of Health” and substituting “Executive Director”.

C. Section 349-10A is amended by deleting “Medical Officer of Health” and substituting “Executive Director”.

D. Sections 349-13A, B, C, D(2), E, E(1) and F are amended in each case by deleting “Medical Officer of Health” where it appears and substituting “Executive Director”.

E. Sections 349-14A and B are amended in each case by deleting “Medical Officer of Health” where it appears and substituting “Executive Director”.

F. Sections 349-15A and B are amended in each case by deleting “Medical Officer of Health” and substituting “Executive Director”.

G. Section 349-18A is amended by deleting “Medical Officer of Health” and substituting “Municipal Licensing and Standards Division”.

H. Sections 349-19, 349-19A and B are amended in each case by deleting “Medical Officer of Health” where it appears and substituting “Executive Director”.

I. Sections 349-20A, B, C(2), D, D(1) and E are amended in each case by deleting “Medical Officer of Health” where it appears and substituting “Executive Director”.

J. Section 349-21B is amended by deleting “Medical Officer of Health” and substituting “Executive Director”.

- K. Section 349-22A is amended by deleting “Medical Officer of Health” and substituting “Executive Director”.
- L. Section 349-24 is amended by deleting “Medical Officer of Health” and substituting “Executive Director”.

3. Chapter 441, Fees and Charges.

- A. Appendix C, Schedule 11, Public Health, of Chapter 441, Fees and Charges, is amended by deleting the following:
