## CITY OF TORONTO

### BY-LAW No. 518-2009

#### To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Corby Avenue and McRoberts Avenue.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. That Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Corby Avenue	South	Gilbert Avenue and McRoberts Avenue	Anytime
McRoberts Avenue	West	Rogers Road and a point 201 metres north of Corby Avenue	Anytime

2. That Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Corby Avenue	South	Gilbert Avenue and McRoberts Avenue	Anytime except the 1st and 3rd Wed. of each month, Apr. 1st to Nov. 30th, inclusive
Corby Avenue	North	Gilbert Avenue and McRoberts Avenue	1st and 3rd Wed. of each month, Apr. 1st to Nov. 30th, inclusive

McRoberts Avenue	West	Rogers Road and a point 201 metres north of Corby Avenue	Anytime except the 1st and 3rd Wed. of each month, Apr. 1st to Nov. 30th, inclusive
McRoberts Avenue	East	Rogers Road and a point 201 metres north of Corby Avenue	1st and 3rd Wed. of each month, Apr. 1st to Nov. 30th, inclusive
