CITY OF TORONTO

BY-LAW No. 732-2009

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Oakwood Village Business Improvement Area and to establish a Board of Management for the Oakwood Village Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 1262-2008, designated an area along area along Oakwood Avenue, between just south of Earlsdale Avenue and Bude Street, including the lands between 616 and 637 Vaughan Road, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

WHEREAS by the adoption of Economic Development Committee Item 20.6 at its meeting of April 29 and 30, 2009, City of Toronto Council established a board of management for the Oakwood Village Business Improvement Area, and appointed members to the Oakwood Village Business Improvement Area Board of Management for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Oakwood Village Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Oakwood Village Board of Management as set out in Schedule A attached; and
 - B. Schedule A, Maps is amended by adding the attached Maps 1 to 3 of the Oakwood Village Business Improvement Area.
2. A Board of Management for the Oakwood Village Business Improvement Area is hereby established.

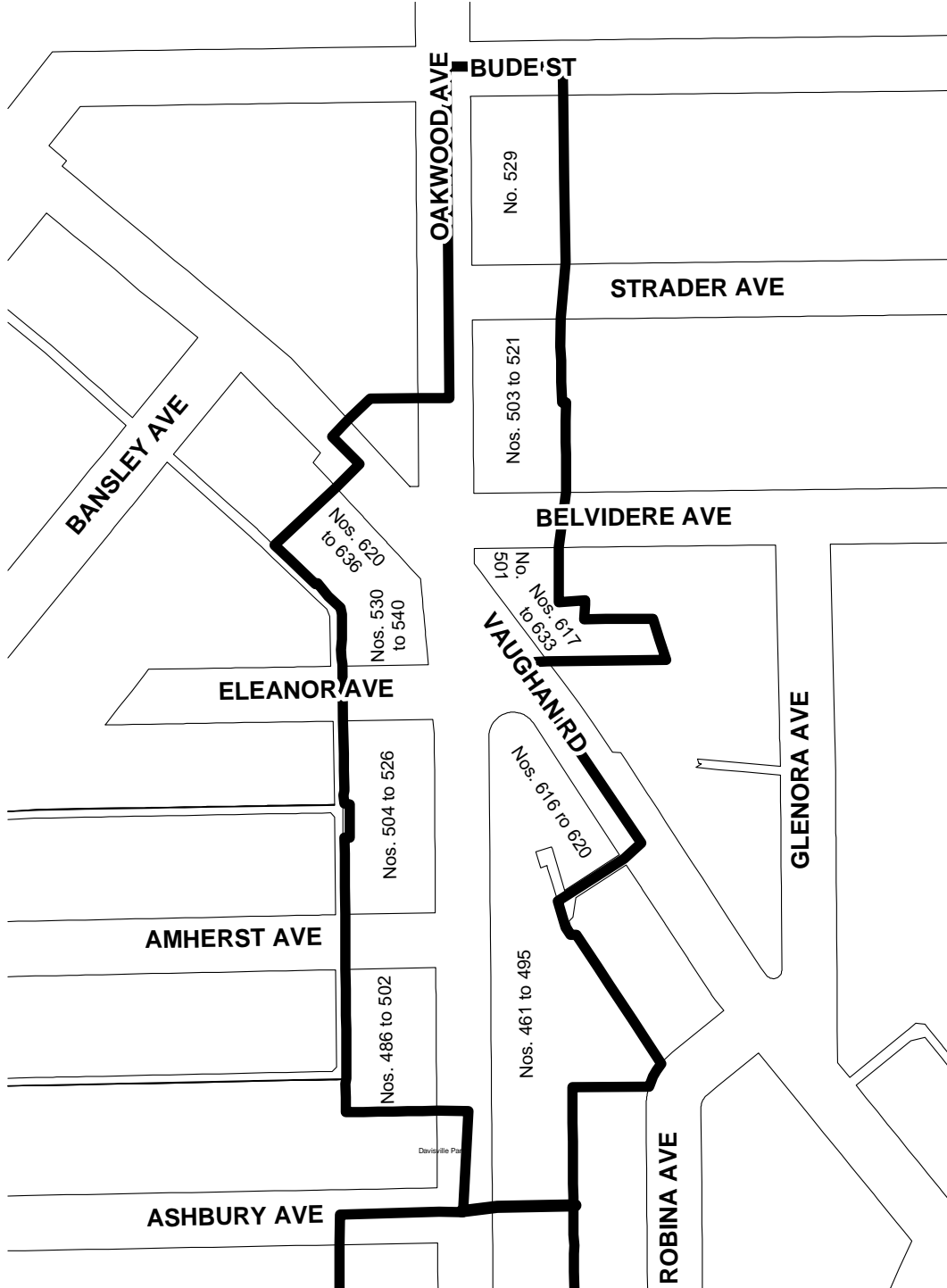

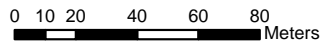

MAP 1 of 3**



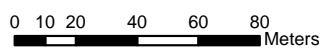
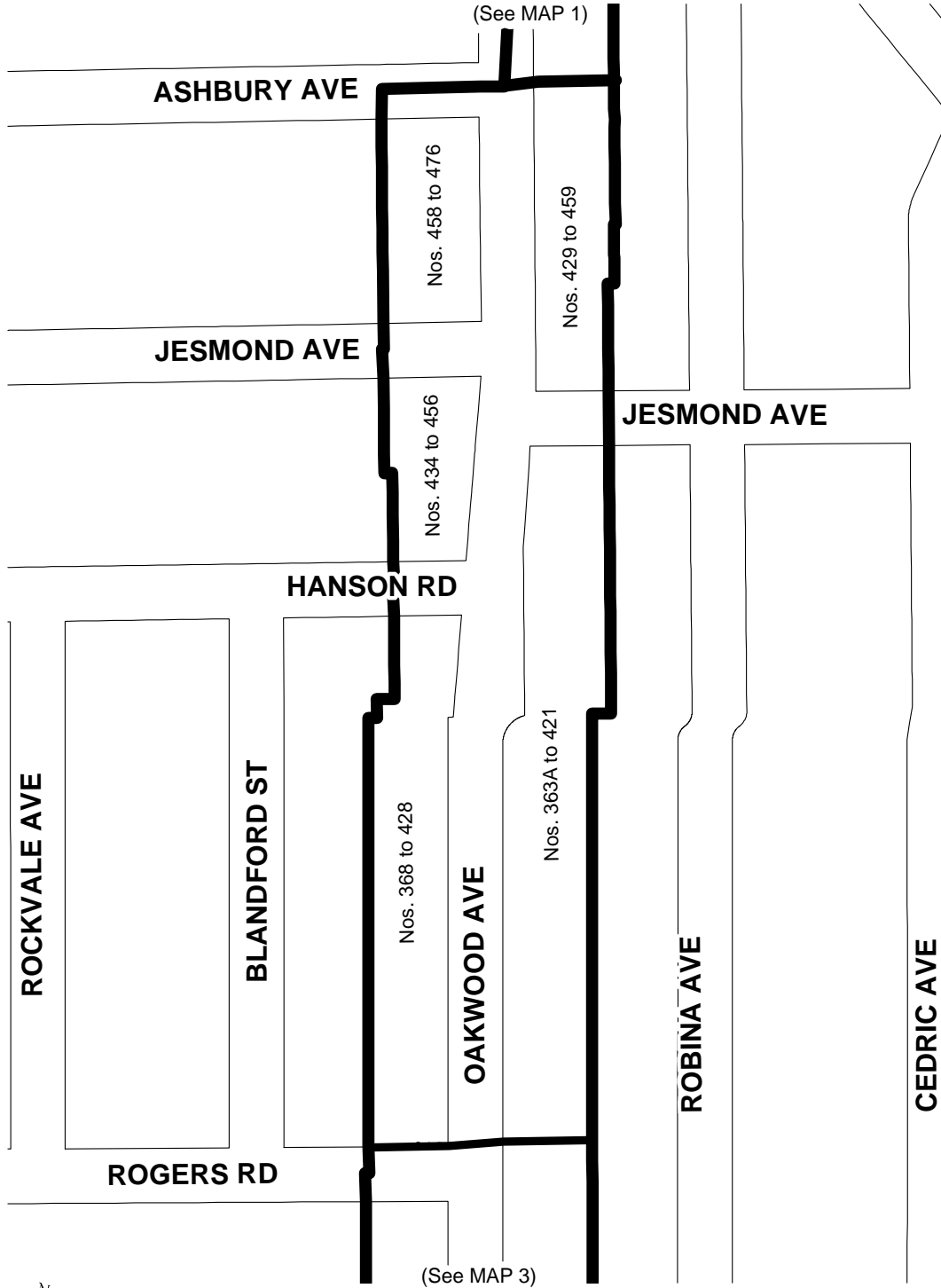

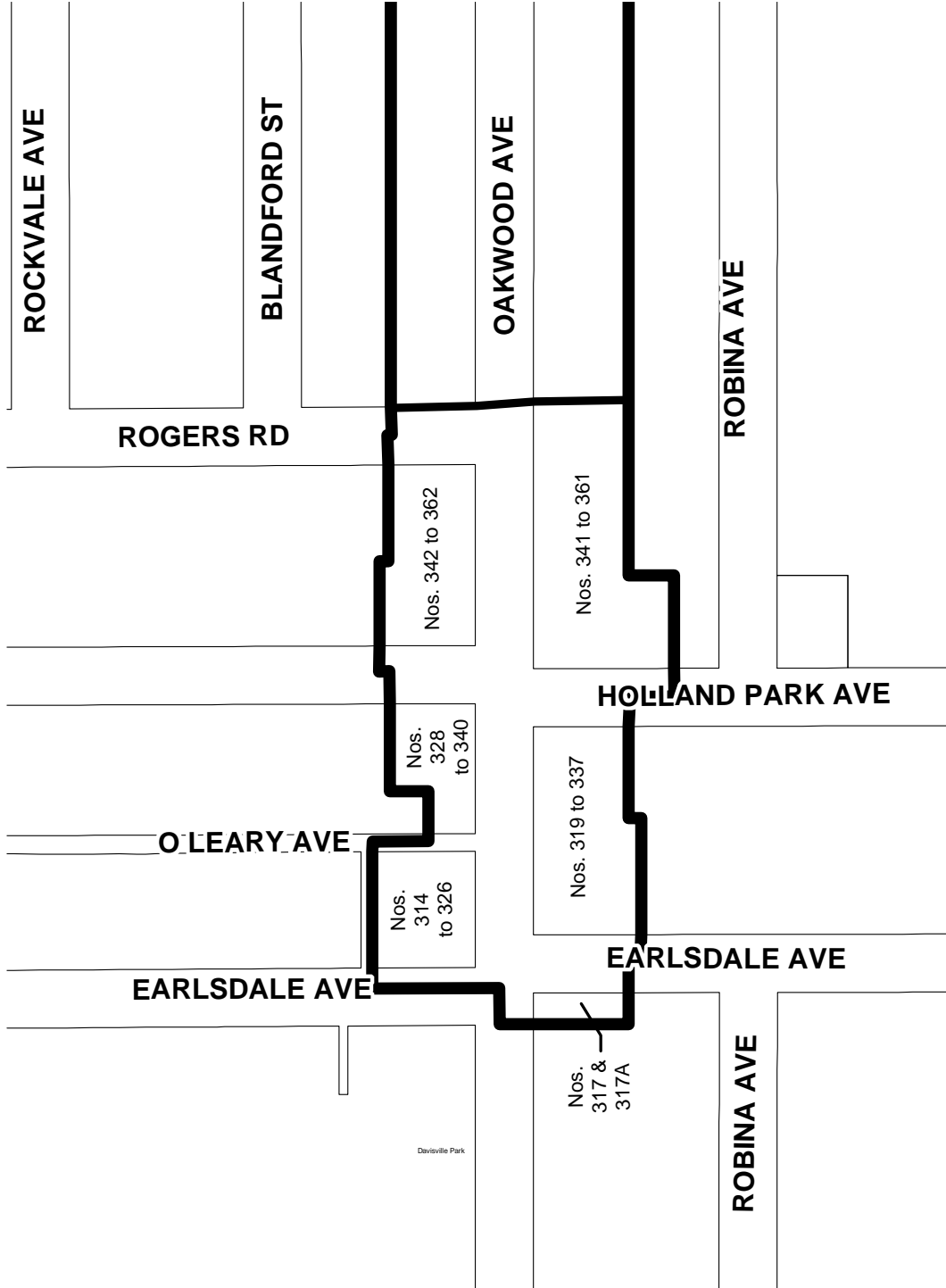
