**CITY OF TORONTO**

**BY-LAW No. 747-2009**

**To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Bloor Street West.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures where they appear opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Bloor Street (M.T. 10)	Both	Highway No. 427 and the west limit of the City of Etobicoke	Anytime
Bloor Street (M.T. 10)	North	The East Mall and a point 152.5 Metres east thereof	8:00 a.m. to 6:00 p.m. except Sundays and Public Holidays
Bloor Street (M.T. 10)	South	The East Mall and a point 172.0 Metres east thereof	Anytime
Bloor Street (M.T. 10)	South	Kipling Avenue and Jopling Avenue	Anytime

where they appear opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

Bloor Street West	South	Kipling Avenue and Beamish Drive	Anytime

2. Schedule IX (No Stopping) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

Bloor Street West	North	Ashbourne Drive and a point 45 metres west of Botfield Avenue	Anytime
Bloor Street West	North	A point 60 metres east of Mill Road and a point 45 metres east of Laurel Avenue	Anytime
Bloor Street West	North	A point 50 metres west of Shaver Avenue North and Charleston Road	Anytime
Bloor Street West	South	A point 60 metres east of Mill Road and Beamish Drive	Anytime

3. Schedule XIV (Left Turn Lanes Only) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by inserting the following words and figures opposite each other in Columns 1 and 2 of the said Schedule:

(In Column 1)	(In Column 2)
Bloor Street West	The East Mall and Shaver Avenue North/Shaver Avenue South
Bloor Street West	Forestview Road and Markland Drive
Bloor Street West	Markland Drive and Leavenworth Crescent
Bloor Street West	Shaver Avenue North/Shaver Avenue South and Poplar Avenue
