BY-LAW No. 790-2009

To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Glenmount Avenue, Hillmount Avenue and Viewmount Avenue.

The North York Community Council HEREBY ENACTS as follows:
