BY-LAW No. 801-2009

To name the public lane north of Gerrard Street East extending from Central Hospital Lane to Parliament Street as “Woodward Evans Lane”.

WHEREAS City of Toronto Council has delegated the legislative authority for local routine matters, such as the naming of public lanes, to Community Councils by adopting Executive Committee Item 2.5, as amended, at its meeting held on February 5, 6, 7 and 8, 2007; and

WHEREAS pursuant to § 27-152E(5) of Chapter 27, Council Procedures, of The City of Toronto Municipal Code, Toronto and East York Community Council has the authority to pass a by-law naming the public lane;

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Certain land comprised of the public lane north of Gerrard Street East extending from Central Hospital Lane to Parliament Street, described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

In the City of Toronto and Province of Ontario, in the Land Titles Division of the Toronto Registry Office (No. 66), being composed of:

FIRSTLY:

Part of PIN 21088-0076 (LT)

Part of the Lane on Plan D-11 abutting the southerly limit of Lot VII on Plan D-11 being a lane north of Gerrard Street East extending from Central Hospital Lane to Seaton Street

SECONDLY:

Part of PIN 21088-0139 (LT)

The Lane on Plan D-2 abutting the northerly limit of Block I I on Plan D-2 and part of Block II on Plan D-2 designated as PART 3 on Plan 63R-2625 and PART 5 on Plan 63R-1682 being a Lane north of Gerrard Street East extending between Seaton Street and Ontario Street

THIRDLY:

Part of PIN 21088-0194 (LT)

The Lane in Block C on Plan D-138 abutting the southerly limits of Lot 6 on the east side of Ontario Street and Lot 14 on the west side of Berkeley Street on Plan D-138, and parts of Lots J and K on Plan D-292 designated as PARTS 1 and 2 on Plan 63R-4708 being a Lane north of Gerrard Street East extending between Ontario Street and Berkeley Street

FOURTHLY:

Part of PIN 21088-0253 (LT)

The Lane in Block D on Plan D-138 abutting the southerly limits of Lots 7 and 14 on the east side of Berkeley Street in Block D on Plan D-138, parts of Lots A, B, C, D, E on Plan 372, part of Lot 3 in Block B on Plan D-138 and part of Lot H on Plan D-292 designated as PARTS 1 and 2 on Plan 63R-4672 being a Lane north of Gerrard Street East extending between Berkeley Street and Parliament Street

is named as “Woodward Evans Lane”.
