CITY OF TORONTO

BY-LAW No. 871-2009

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Brookmount Road, Columbine Avenue, Dixon Avenue, Lark Street, Lockwood Road and Rainsford Road.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:
