BY-LAW No. 878-2009

To confirm the proceedings of Toronto and East York Community Council at its meeting held on the 15th day of September, 2009 as it relates to decisions made under delegated authority.

The Toronto and East York Community Council HEREBY ENACTS as follows:

- 2.** The Mayor and the proper officers of the City are authorized and directed to do all things necessary to give effect to the action or to obtain approvals where required, and except where otherwise provided, the City Clerk and the Deputy City Manager and Chief Financial Officer are authorized and directed to execute all documents necessary in that behalf and to affix the corporate seal of the City to the documents.
- 3.** This By-law, to the extent to which it provides authority for or constitutes the exercise by the Community Council of its powers to proceed with, or to provide any money for, any undertaking, work, project, scheme, act, matter or thing which requires an approval in addition to the approval of the Community Council, shall not take effect until the additional approval has been obtained.
