**CITY OF TORONTO**

**BY-LAW No. 896-2009**

**To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Bridgeland Avenue at Caledonia Road.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- Schedule “XIII” (One-Way Traffic Lanes) of By-law No. 31001, of the former City of North York, is amended by deleting from Columns 1, 2, 3, 4, 5 and 6 the following:
