CITY OF TORONTO

BY-LAW No. 911-2009

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, to amend the definition of Excluded Area.

WHEREAS it is desirable to make amendments to The City of Toronto Municipal Code Chapter 925, Permit Parking, in order to amend the definition of Excluded Area;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Section 925-1B of City of Toronto Municipal Code Chapter 925, Permit Parking, is amended by deleting the definition of EXCLUDED AREA and inserting in lieu thereof the following definition of EXCLUDED AREA:

“EXCLUDED AREA — means:

- (1) The area bounded by Steeles Avenue on the north, Highway 401 on the south, Victoria Park Avenue on the east, the Humber River on the west, and the area bounded on the north by Highway 401, on the east by Victoria Park Avenue, on the south by the CPR line to Sunrise Avenue or Northline Road, and on the west by the CNR line from Highway 401 to Don Mills Road and from Don Mills Road to the CPR line;
- (2) The area bounded by Steeles Avenue East on the north, Lake Ontario on the south, Victoria Park Avenue on the west, and Pickering Town Line to the Rouge River and the Rouge River to Lake Ontario on the east, save and except the following streets/areas:
 - (a) The area bounded by Victoria Park Avenue on the west, Danforth Avenue on the north, Warden Avenue on the east, and the Canadian National Railway (Kingston Subdivision) on the south;
 - (b) The area bounded by Victoria Park Avenue on the west, Gerrard Street East on the north, Blantyre Avenue on the east, and Kingston Road on the south;
 - (c) The area bounded by Victoria Park Avenue on the west, Kingston Road on the north, Fallingbrook Road on the east, and Queen Street East on the south;
 - (d) Haig Avenue from Kingston Road to the south end of Haig Avenue;
 - (e) Warden Avenue from Kingston Road to the south end of Warden Avenue;
and

- (f) Queensbury Avenue from Kingston Road to a point 300 metres north of Kingston Road.
- (3) The boundary streets mentioned in Subsections (2)(a), (b) and (c), but not:
 - (a) Fallingbrook Road south of Kingston Road; or
 - (b) the east side of Victoria Park Avenue between Kingston Road and Bracken Avenue and both sides of Victoria Park Avenue south of Bracken Avenue.”
