BY-LAW No. 914-2009

To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Eglinton Avenue West and Old Forest Hill Road.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule XV (Prohibited Turns) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

Eglinton Avenue West and Old Forest Hill Road (M.T. 18)	Northbound	Left	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday to Friday except Public Holidays (bicycles excepted)

2. Schedule XVI (Compulsory Turns) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2 and 3 of the said Schedule:
