## CITY OF TORONTO

### BY-LAW No. 958-2009

#### To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Bloor Street East and Bloor Street West.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule IV (Stands for Taxicabs) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by striking out the words and figures:

Bloor Street North East (M.T. 10)	A point 128.5 metres east of Yonge Street and a point 14 metres further east thereof	2	Anytime
Bloor Street South East (M.T. 10)	A point 70 metres east of Yonge Street and a point 20 metres further east thereof	3	Anytime except 7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m. Monday to Friday

where they occur opposite each other in Columns 1, 2, 3, 4 and 5 of the said Schedule and inserting in lieu thereof the following:
