CITY OF TORONTO

BY-LAW No. 981-2009

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to reflect the expanded boundaries of the St. Clair Gardens Business Improvement Area.

WHEREAS Chapter 19, Business Improvement Areas of The City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas, including the St. Clair Gardens Business Improvement Area; and

WHEREAS by the enactment of By-law No. 980-2009 at its meeting of September 30 and October 1, 2009, City of Toronto Council designated an area that includes the existing St. Clair Gardens Business Improvement Area (as described in former City of Toronto By-law No. 59-85 and City of Toronto By-law No. 994-2004) as an improvement area; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas must be amended to reflect the designation of the expanded St. Clair Gardens Business Improvement Area; and

WHEREAS the St. Clair Gardens designating by-law number set out in the “Designating By-law (Former Municipality)” column of the table in Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas has been incorrectly transcribed as “995-2004” and should read “994-2004”;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended by deleting By-law No. “995-2004” beside the name “St. Clair Gardens” in the “Designating By-law (Former Municipality)” column and substituting “By-law No. 980-2009”; and
 - B. Schedule A, Maps is amended by deleting the maps of the St. Clair Gardens Business Improvement Area and substituting Maps 1 and 2 of the St. Clair Gardens Business Improvement Area attached to this by-law.

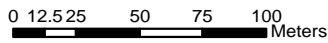
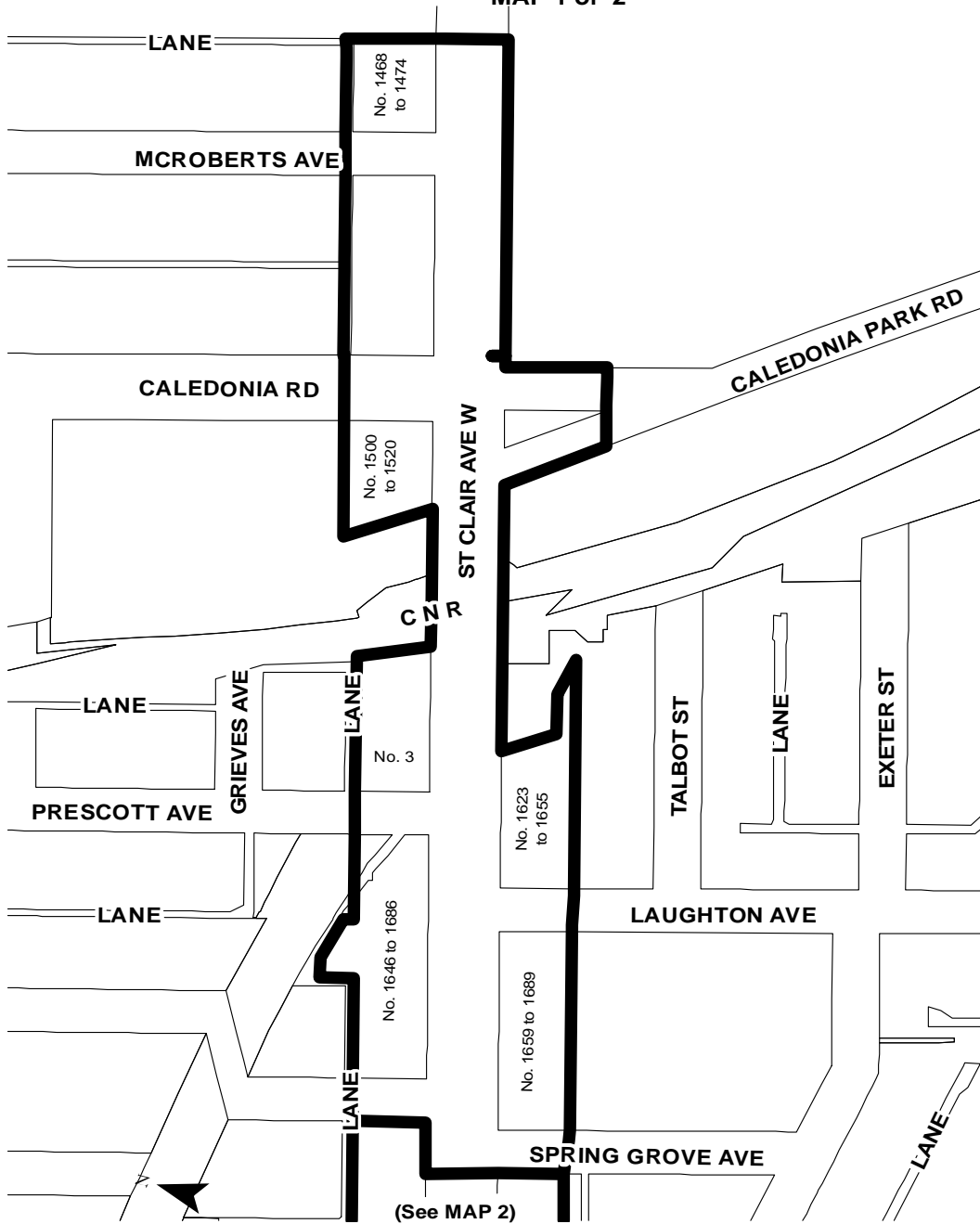

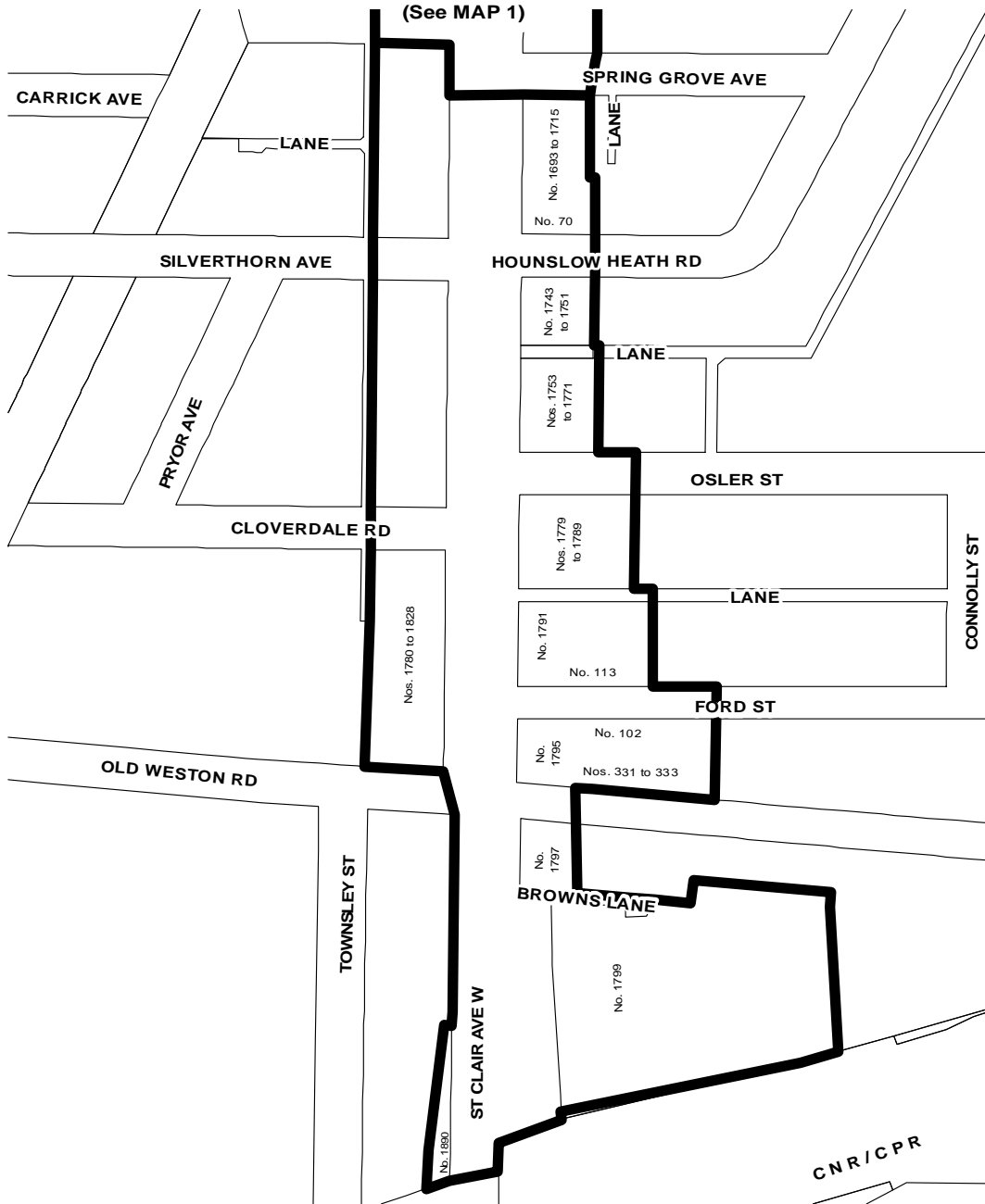
