## **CITY OF TORONTO**

### **BY-LAW No. 996-2009**

#### **To amend further By-law No. 380-74 of the former Corporation of the City of Toronto respecting civic employees' pensions and other benefits.**

WHEREAS By-law No. 380-74 of the former Corporation of the City of Toronto, a by-law "To establish a pension plan to be known as the '1974 Improved Plan' ", as heretofore amended, governs the Toronto Civic Employees Pension and Benefit Fund; and

WHEREAS it is desired to correct certain typographical errors in By-law No. 1025-2008 which amended said By-law No. 380-74;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. In this by-law, "By-law No. 380-74" shall mean By-law No. 380-74, as amended, of the former Corporation of the City of Toronto.
2. By-law No. 1025-2008 is amended by striking out
  - (a) in the first line of clause 4(1)(a) thereof the text "paragraph (a)" and substituting therefor "each of paragraphs (a) and (b)";
  - (b) in clause 4(1)(c) thereof
    - (i) the text "paragraph (c)" in the first line and substituting therefor "each of paragraphs (c) and (d)"; and
    - (ii) the text "paragraph (2.2)(a)" in the second line and substituting therefor "subsection (2.4)";
  - (c) in clause 4(1)(d) thereof
    - (i) the text "paragraph (e)" in the first line and substituting therefor "each of paragraphs (e) and (f)"; and
    - (ii) the text "(2.3)" in the second line and substituting therefor "(2.2)";
  - (d) in the second line of subclause 4(1)(e)(i) thereof the text "(2.3)(b)" and substituting therefor "(2.3)(a)";
  - (e) in the second line of subclause 4(1)(f)(i) thereof the text "subject to" and substituting therefor "subject to paragraphs (2.1)(c), (2.2)(c), (2.3)(b) and (2.4)(c), and";

- (f) in the text of clause 15(2.1)(a) of By-law No. 380-74 as added by subsection 4(3) of By-law No. 1025-2008, the text “paragraph (2)(a)” and substituting therefor “paragraphs (2)(a) and (b)”;
  - (g) in the text of clause 15(2.2)(a) of By-law No. 380-74 as added by subsection 4(3) of By-law No. 1025-2008, the text “paragraph (2)(e)” and substituting therefor “paragraphs (2)(e) and (f)”;
  - (h) in subsection 4(4) thereof, clause (a) and the label of clause (b), without replacement.
- 3.** By-law No. 1025-2008 is further amended by modifying the text of subsection 15(2.4) of By-law No. 380-74 as added by subsection 4(3) of the first-mentioned By-law so as to
- (a) insert immediately preceding the text “subsection (6)” in the first line of clause (a) the text “paragraph (2)(d), ”;
  - (b) strike out immediately following the concluding semi-colon of clause (a) the word “and” without replacement; and
  - (c) insert immediately following the concluding semi-colon of clause (b) the word “and”.
- 4.** This by-law shall be deemed to have come into force on the 25th day of September, 2008.
