**CITY OF TORONTO**

**BY-LAW No. 1009-2009**

**To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads and to amend By-law No. 32759 of the former City of North York, respecting school bus loading zones on North York Roads, regarding Estelle Avenue.**

The North York Community Council HEREBY ENACTS as follows:

- Schedule “VIII” (No Parking) of By-law No. 31001, of the former City of North York, is amended by deleting from Columns 1, 2, 3 and 4 the following:
