BY-LAW No. 1010-2009

To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads and to amend By-law No. 32759 of the former City of North York, respecting school bus loading zones on North York Roads, regarding Kempford Boulevard.

The North York Community Council HEREBY ENACTS as follows:

1. Schedule "VIII" (No Parking) of By-law No. 31001, of the former City of North York, is amended by adding to Columns 1, 2, 3 and 4 the following:
