BY-LAW No. 1040-2009

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Carlton Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Carlton Street	South	A point 35.1 metres east of Sackville Street and Sumach Street	8:30 a.m. to 5:00 p.m., Mon. to Fri.

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Carlton Street	South	A point 35.1 metres east of Sackville Street and a point 6 metres east of Bowman Avenue	8:30 a.m. to 5:00 p.m., Mon. to Fri.
Carlton Street	South	A point 61 metres east of Bowman Avenue and Sumach Street	8:30 a.m. to 5:00 p.m., Mon. to Fri.
Carlton Street	South	A point 6 metres east of Bowman Avenue and a 55 metres further east	8:00 a.m. to 8:30 a.m., 9:15 a.m. to 11:15 a.m., 1:15 p.m. to 3:15 p.m. and 3:45 p.m. to 5:00 p.m. Mon. to Fri.

C. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:
