CITY OF TORONTO

BY-LAW No. 1093-2009

To amend City of Toronto Municipal Code Chapter 608, Parks, to change certain definitions, to allow working dogs providing a service to the City on swimming beaches and prohibited areas at all times, and to restrict swimming beach access to other dogs.

WHEREAS under sections 7 and 8 of the *City of Toronto Act*, 2006 (the "Act"), the City may pass by-laws respecting the use of its parks system; and

WHEREAS Council has approved changes to City of Toronto Municipal Code Chapter 608, Parks to allow working dogs providing a service to the City on swimming beaches and prohibited areas at all times, and to restrict swimming beach access to other dogs; and

WHEREAS City of Toronto Municipal Code Chapter 608, Parks must be amended to reflect the changes to such access;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. Chapter 608, Parks, of the City of Toronto Municipal Code is amended as follows:
- A. Section 608-1 is amended as follows:
 - (1) By deleting the definition of "BLUE FLAG BEACH".
 - (2) By deleting "or blue flag designated beaches" from Subsection H of the definition of "PROHIBITED AREAS".
 - (3) By adding the following after "SPECIAL EVENT":
 - "SWIMMING BEACH A pebbly or sandy shore on Lake Ontario maintained and supervised by the City for bathing, swimming, sun bathing and other recreational activities."
- B. Section 608-34 is amended as follows:
 - (1) Subsection A is amended as follows:
 - (a) By deleting Subsection A(1) and (2) and substituting the following:
 - "(1) Excluding a working dog providing a service to the City, allow the dog to run at large, except in a posted designated off-leash area.
 - (2) Excluding blind persons reliant upon a guide dog, and a working dog providing a service to the City, allow the dog to enter a prohibited area."

- (b) By deleting "or" in Subsection A(3).
- (c) By deleting the period in Subsection A(4) and substituting "; or".;
- (d) By adding the following:
 - "(5) Excluding blind persons reliant upon a guide dog, and a working dog providing a service to the City, allow the dog to enter a swimming beach except between November 1 and March 31."
- (2) Subsection B is re-numbered as Subsection C and the following is added as a new Subsection B:
 - "B. Despite § 608-34A(5), dogs are permitted off-leash below the snow fence line at Kew-Balmy Beach and Woodbine Beach between November 1 and March 31."
- 2. This by-law shall come into force on the day after the set fine order is issued by the Regional Senior Judge of the Ontario Court of Justice.
