BY-LAW No. 75-2011

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Armadale Avenue, Aziel Street, Jasper Avenue, Lauder Avenue, McRoberts Avenue, Silverthorn Avenue, Teignmouth Avenue, Vine Avenue, White Avenue, Willard Avenue and Windermere Avenue.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, of the City of Toronto is amended as follows:

A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

| Armadale Avenue | West | A point 77 metres south of Ardagh Street and a point 5.5 metres further south | Anytime |
| Silverthorn Avenue | West | A point 34 metres north of Turnberry Avenue and a point 5.5 metres further north | Anytime |

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

|------------------|------------------|---|------------------|
| Aziel Street | East | A point 130 metres south of Annette Street and a point 5.5 metres further south | Anytime |
| Jasper Avenue | South | A point 110.5 metres west of Weston Road and a point 5.5 metres further west | Anytime |
| Lauder Avenue | West | A point 29.5 metres north of Cloverlawn Avenue and a point 5.5 metres further north | Anytime |

| McRoberts Avenue | East | A point 1 metre south of a point opposite the south curb of Corby Avenue and a point 5.5 metres further north | Anytime |
| Teignmouth Avenue | South | A point 9 metres west of Boon Avenue and a point 5.5 metres further west | Anytime |
| Vine Avenue | South | A point 102 metres west of Keele Street and a point 5.5 metres further west | Anytime |
| White Avenue | South | A point 49 metres east of Florence Crescent and a point 5.5 metres further east | Anytime |
| Willard Avenue | West | A point 48 metres north of Ardagh Street and a point 5.5 metres further north | Anytime |
| Windermere Avenue | East | A point 57 metres south of Deforest Road and a point 5.5 metres further south | Anytime |
