## **CITY OF TORONTO**

### **BY-LAW No. 122-2011**

#### **To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to make changes to the size of various Business Improvement Area Boards of Management.**

WHEREAS Chapter 19, Business Improvement Areas, of The City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas; and

WHEREAS Toronto and East York Community Council, under delegated authority, has approved the removal of some members from some Boards of Management, and the appointment of members to various Business Improvement Area Boards of Management, for a term expiring on November 30, 2014, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to reflect the change in the number of members and the number required for quorum of the various Business Improvement Area Boards of Management;

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. The table in Schedule A of the Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - (1) by changing the number of members of The Beach Business Improvement Area Board of Management to 15 and the number required for quorum to 6;
  - (2) by changing the number of members of the Bloor Annex Business Improvement Area Board of Management to 9 and the number required for quorum to 4;
  - (3) by changing the number of members of the Bloorcourt Village Business Improvement Area Board of Management to 15;
  - (4) by changing the number of members of the Bloordale Village Business Improvement Area Board of Management to 6 and the number required for quorum to 3;
  - (5) by changing the number of members of the Bloor Street Business Improvement Area Board of Management required for quorum to 3;
  - (6) by changing the number of members of the Bloor-Yorkville Business Improvement Area Board of Management to 15 and the number required for quorum to 8;

- (7) by changing the number of members of the Cabbagetown Business Improvement Area Board of Management to 16;
- (8) by changing the number of members of the Church Wellesley Village Business Improvement Area Board of Management to 15;
- (9) by changing the number of members of The Danforth Business Improvement Area Board of Management to 11;
- (10) by changing the number of members of the Danforth Mosaic Business Improvement Area Board of Management to 20 and the number required for quorum to 7;
- (11) by changing the number of members of the Danforth Village Business Improvement Area Board of Management to 14 and the number required for quorum to 5;
- (12) by changing the number of members of the Dovercourt Village Business Improvement Area Board of Management to 8;
- (13) by changing the number of members of the Downtown Yonge Business Improvement Area Board of Management to 14;
- (14) by changing the number of members of the Forest Hill Village Business Improvement Area Board of Management to 8;
- (15) by changing the number of members of the Gerrard India Bazaar Business Improvement Area Board of Management to 15;
- (16) by changing the number of members of the Greektown on the Danforth Business Improvement Area Board of Management to 15 and the number required for quorum to 6;
- (17) by changing the number of members of the Harbord Street Business Improvement Area Board of Management to 8 and the number required for quorum to 4;
- (18) by changing the number of members of the Kensington Market Business Improvement Area Board of Management to 11 and the number required for quorum to 4;
- (19) by changing the number of members of the Korea Town Business Improvement Area Board of Management to 14;
- (20) by changing the number of members of the Liberty Village Business Improvement Area Board of Management required for quorum to 10;
- (21) by changing the number of members of the Little Portugal Business Improvement Area Board of Management to 11 and the number required for quorum to 4;

- (22) by changing the number of members of the Mirvish Village Business Improvement Area Board of Management to 8;
- (23) by changing the number of members of the Mount Pleasant Business Improvement Area Board of Management to 6;
- (24) by changing the number of members of the Pape Village Business Improvement Area Board of Management to 8;
- (25) by changing the number of members of the Parkdale Village Business Improvement Area Board of Management to 12;
- (26) by changing the number of members of the Queen Street West Business Improvement Area Board of Management to 13;
- (27) by changing the number of members of the Roncesvalles Village Business Improvement Area Board of Management to 20 and the number required for quorum to 9;
- (28) by changing the number of members of the Rosedale Main Street Business Improvement Area Board of Management to 14 and the number required for quorum to 6;
- (29) by changing the number of members of the Toronto Entertainment District Business Improvement Area Board of Management to 21;
- (30) by changing the number of members of The Waterfront Business Improvement Area Board of Management to 13 and the number required for quorum to 6; and
- (31) by changing the number of members of the West Queen West Business Improvement Area Board of Management to 17 and the number required for quorum to 7.
