## BY-LAW No. 139-2011

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Bain Avenue, Baltic Avenue, Bertmount Avenue, Craven Road, East Lynn Avenue, Geoffrey Street, Glendale Avenue, Hallam Street, Herbert Avenue, Huron Street, Major Street, Milverton Boulevard, Normandy Boulevard, Paton Road, Perth Avenue, Silver Avenue, Stewart Street, Waverley Road and Wildwood Crescent.

The Toronto and East York Community Council HEREBY ENACTS as follows:

- **1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
