BY-LAW No. 168-2011

To amend By-law No. 31878, of the former City of North York respecting maximum rates of speed on North York roads, regarding Ancaster Road, Gilley Road, Home Road, Katherine Road, Keswick Road, Maniza Road, Murray Road, Plewes Road, Powell Road, Regent Road and Spalding Road.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. That Section 1 of By-law No. 31878 of the former City of North York is amended by deleting the following:

<u>HIGHWAY</u>	<u>FROM</u>	<u>TO</u>
ANCASTER ROAD	THE NORTHERLY LIMIT OF REGENT RD.	THE SOUTHERLY LIMIT OF PLEWES RD.
KATHERINE ROAD	A POINT 30M WEST OF GARRATT BLVD.	THE WESTERLY LIMIT OF ANCASTER RD.
MANIZA ROAD	THE SOUTHERLY LIMIT OF REGENT RD.	THE SOUTHERLY LIMIT OF HOME RD.
PLEWES ROAD	THE WESTERLY LIMIT OF ANCASTER RD.	THE WESTERLY LIMIT OF KESWICK RD.
SPALDING ROAD	A POINT 30M WEST OF GARRATT BLVD.	THE WESTERLY LIMIT OF ANCASTER RD.

2. That Section 1 of By-law No. 31878 of the former City of North York is amended by adding the following:

GILLEY ROAD	GARRATT BOULEVARD	KESWICK ROAD

KATHERINE ROAD	MURRAY ROAD	BEFFORT ROAD
KESWICK ROAD	REGENT ROAD	GILLEY ROAD
MANIZA ROAD	WILSON AVENUE	THE NORTH LIMIT OF MANIZA ROAD
MURRAY ROAD	WILSON AVENUE	PLEWES ROAD
PLEWES ROAD	MURRAY ROAD	KESWICK ROAD
POWELL ROAD	ANCASTER ROAD	THE EAST LIMIT POWELL ROAD
REGENT ROAD	MURRAY ROAD	DUFFERIN STREET
SPALDING ROAD	MURRAY ROAD	KESWICK ROAD

3. That Section 1 of By-law No. 31878, as amended, be the same is hereby confirmed.
